## WORKING TO ACHIEVE CARBON NEUTRALITY

It's heartening to see the rapid growth in numbers of people around the world who are taking practical action for the planet. Early in October over 400 MPs joined Extinction Rebellion's appeal to plant more trees. On October 10<sup>th</sup> the Environment Agency committed to become a net zero organisation by 2030. Emma Howard Boyd, Chair of the EA, said: "Tackling the climate emergency is the biggest challenge facing humankind [...]. We are under no illusion about the scale of the challenge that we have set ourselves, but action is needed if we are to preserve our planet for future generations."

Gareth Redmond-King, Head of Climate Change at WWF-UK, notes that the UK will host a global climate summit in 2020. This is "a major opportunity to show international leadership in tackling this planetary emergency. But we must demonstrate we're walking the talk at home by taking rapid and ambitious action to reduce our emissions in a way that also helps people and communities."

## Report from Centre for Alternative Technology

For the last 45 years CAT has conducted research, developed resources and provided training. Rob and Gill went to Hereford on October 1<sup>st</sup> to hear Paul Allen, a scientist from CAT, talk about Zero Carbon Britain. They were encouraged to hear him explain that all the technologies needed for net carbon neutrality are available now. Much of our familiar lifestyle could be maintained by redirecting resources to support these technologies in place of the current systems that depend on fossil fuels. 
