The refurbished property we mentioned in our winter newsletter is now occupied.

Another one has become vacant and we had two local expressions of interest while the painters and decorators were there. Both parties have applied and the first one is going through referencing. With the painting all done, we're now pricing carpets and lino. The side fences will be replaced as soon as the contractor can obtain the materials he needs – and the next-door neighbour is happy to pay half the cost.

Earlier this year the National Landlords Association (NLA) merged with the Residential Landlords Association (RLA) to form the National Residential Landlords Association (NRLA). Over the years we have often turned to the NLA for guidance, so it's reassuring to see that our membership has moved across to the NRLA without a hitch. A form letter arrived recently from the NRLA, outlining the help that's available when tenants request a lower rent because Covid-19 is reducing their income. We've already received one such request so the NRLA letter came in quite handy. We hope to agree a manageable interim rent level with the tenants, plus a payment plan to cover the arrears they will build up.

PROPERTY DEVELOPMENT IN SOUTH WALES

On March 24th Rob and Gill were due to meet with two staff members at Swansea Council: a senior planning officer and an enforcement officer. This was cancelled because of the virus and we were offered a Skype meeting instead. When that proved too complicated to co-ordinate on the day, Rob had a phone conversation with just the senior planning officer. It was a useful discussion, identifying the next steps we need to take before we can apply for planning permission. For instance, we'll need to find a highways specialist who can advise us about the visibility splay that our proposed development will require.

Working through the list of tasks is taking longer than usual because so many people are working remotely (as are we), away from familiar colleagues, documents and filing systems. This means communication timescales are stretching ever longer – but we like a challenge, especially when it's in a good cause.
